The applicant shall apply to the Federal Office of Communications (OFCOM) using this form (completed truthfully and in full) for the allocation of an individual number in accordance with Art. 4 and 24c of the Ordinance on Addressing Resources in the Telecommunications Sector (AEFV; SR 784.104) of 6 October 1997.

Only **one** individual number can be requested per application form.
